Terms and Conditions

Renter must be 21 years of age or older. Valid identification must be provided prior to boarding the bus.

Renter Responsibility

The renter is responsible for all activities of the passengers on board the bus. This includes making sure that all passengers do not consume alcohol on the bus. In the event that your passengers drink alcohol on DSH buses, this will result in a \$50/bus fee that will be charged to the credit card on file.

Bus Deposit and Cancellation

In order to secure your transportation, we will need a **50% per bus deposit**. The deposit will be cashed upon receiving. **The deposit check can be made out to Kate Copeland and mailed to 3777 Walnut Grove Way Gainesville, GA 30506.** You may also send this via Venmo or CashApp. Please consult office for these resources. **If you choose to cancel your reservation within 7 days prior to your reservation date, you will forfeit your deposit/any contributed funds.** Anything outside of those 7 days if you should cancel, you will receive your refund minus \$50 per bus.

If there is any damage to the bus(s) or excessive cleanup is required, a damage assessment will be made and all or a portion of your deposit will be forfeited. Any damage assessment will be determined once the bus has returned to the shop and has been thoroughly cleaned.

Payment

Full payment must be received two weeks prior to boarding the bus regardless of payment method. Proof of payment will be required.



Alcohol Policy

Non-alcoholic beverages are permitted, while alcoholic beverages are not allowed. Beverages must be in a closed container and should be brought on board in solid coolers (no soft side, styrofoam, or damages coolers will be permitted). **In the event that your passengers drink alcohol on DSH buses, this will result in a \$50/bus fee that will be charged to the credit card on file or taken out of your deposit.** If you know that your guests will be consuming alcohol while on the bus, please let us know and we will add the charges up front.

Smoking Policy

Smoking of any kind is not permitted in the bus. This includes vaping of any sort.

Rules of Conduct

No fighting, weapons, or drugs will be tolerated. Violation will result in the immediate termination of the bus run. For this violation, there will be no refunds and no exceptions.

Gratuity

Gratuity is not included and is completely left up to the renter's discretion. Should you opt to give a gratuity to your drivers, you may do so in person or we can add it to your invoice and distribute to the drivers on your behalf with your permission.
